- Resolved Billing Provider references and updates Billing Provider lookup to include NPI and Organization name.
- Fixes for Service Line Comments (Notes field on Services tab).
- Resolved issues with the EPO section of the Professional Service tab.
- Fixes for user permissions related to the main menu access, importing claims and security preferences.
- Fixed issues with the Warning Panel routing.
- Fixed issues related to downloading outbound files.
- Resolved issues with the Patient Autofill and Synchronization functionality on Professional Claims screen.
- Fixed for Message Center and corresponding mailboxes.

- Fixed the new warning button on Professional Claims screen.
- Updated for navigation when using the Tab key.
- Updated Batch Manager and Payment Manager search functionality

- Added the ability to add Tags to claims and Remits.
- Added the ability to set a service date when copying a claim.
- Added NPI and cost Label to the top of the Professional Claims form.
- Added Mailbox Providers and Payers under Mailbox Properties.
- Added the ability to add a comment to a Claims Info Section.
- Added the ability to add an Alias for a Payer.
- Added better validation for Bill Codes.
- Added Receiver Payers for Professional Claims Service Date Ranges.
- Added the Insured Name to the Insurance tab of Patient Editor.
- Added the ability to use DM as a Suffix.
- Added resubmission code search functionality to bx 22 on the Professional Claim.
- Added a “Loading” overlay on pages for clarity.
- Added and All-Fields panel to Professional Claims.
- Added additional ZIP code values.
- Added the ability to send Partial Batches.
- Added Advanced Organization Search for System Admin users.
- Added a session timeout after 30 minutes for user inactivity.
- Added additional search capabilities and sorting to Patient List, Mailbox List, Message Center and Batch Manager.
- Added the ability to print the claim information.
- Added the ability to archive multiple records in message center and payment manager at once.
- Added the ability to unarchive a file.
- Added the ability to download and zip multiple files withing the message center.
- Added a column for NPI Option, Sent Files, and Received Files on the Mailboxes grid.
- Added additional Source Name columns to the Message Center grid.
- Added the ability to copy Providers.
